Welcome The Chairman welcomed the steering group campaigning for a CAB in Ayr.

4 Matters Arising

Community Council Elections Community Council elections take place every three years. Nomination Forms are now available and need to be filled in and lodged by 5.00pm on Thursday 21 February. The new Community Council to take effect from 1 April.

High Rise Flats Michael Alexander is the SAC Officer delegated to oversee the project. NM and DP await an invitation to attend the High Rise Flats Working Group involving tenants and SAC representatives regarding the future of the three iconic buildings. The three options are as follows:

- 1. Decant tenants one block at a time to allow renovation.
- 2. Demolition and move tenants elsewhere.
- 3. Demolition and build on site.

One-to-one discussions were taking place with tenants.

5 Steering Group Four members of the steering group advocating a CAB for Ayr each introduced themselves and explained why each could have benefitted from such an independent source of advice if one had been available. The CAB/CAS network is in touch nationwide to keep abreast of the latest information. It is efficient, offers best value and maintains standards whilst it also improves and develops. It offers free, independent advice and is holistic. A high percentage of volunteers together with professionals are involved and thus the system is cost effective. It supports people attending a tribunal hearing. South Ayrshire residents needing advice are disadvantaged. SAC would save on costs if it closed some centres that duplicate advice services.

Community Councillors spoke of good experiences from CABs because they offered nonjudgemental independent advice. One community councillor had been humiliated by the experience of an officer at County Buildings tearing up the form taken in to apply for a care package. There were communication problems between departments located in SAC's different venues.

SB considered that SAC offered comprehensive advice.

MD had approached SAC's CEO calling for a review of advice services but it had not been allowed. There was hope that sense would prevail and that a fresh approach might result in a fresh look at advice services, particularly in view of cost effectiveness of independent advice services.

Community councillors agreed that there is a need for a CAB in Ayr. The steering group had met with various groups but Cllr Douglas Campbell had refused to meet the steering group. One member of the steering group wanted housing advice from outside SAC, and could not find housing advice in SAC accounts. FW was saddened that Ayrshire has no CAB.
